As pessoas frequentemente se perguntam por que não ouviram falar do **EB-3** antes.

Parece tão simples: é uma excelente solução para lidar com um sistema de imigração muito complicado. Algumas pessoas exploram quase todas opções de imigração, contratando advogados, assessores e consultores e nenhum deles mencionou o EB-3. A chave para a questão é que o EB-3 é um programa de imigração comumente usado por empresas nos EUA, mas necessita que o empregador inicie o processo de certificação laboral e esteja envolvido no programa .



Este fato faz com que seja um programa de imigração "**menos conhecido**"



Em 2016, havia 64.000 candidatos a EB-3, dos quais quase 9.000 eram trabalhadores não qualificados. Existem muito poucos, se houver, programas de residência permanente (Green Card) maiores que o EB-3.

Quando as leis de imigração foram revistas em 1990, o governo dos Estados Unidos compreendeu que várias indústrias, como processamentos de alimentos, limpeza comercial, enfermagem e fisioterapia, tinham uma grave escassez de trabalhadores americanos. Foi assim que a imigração EB-3 nasceu.

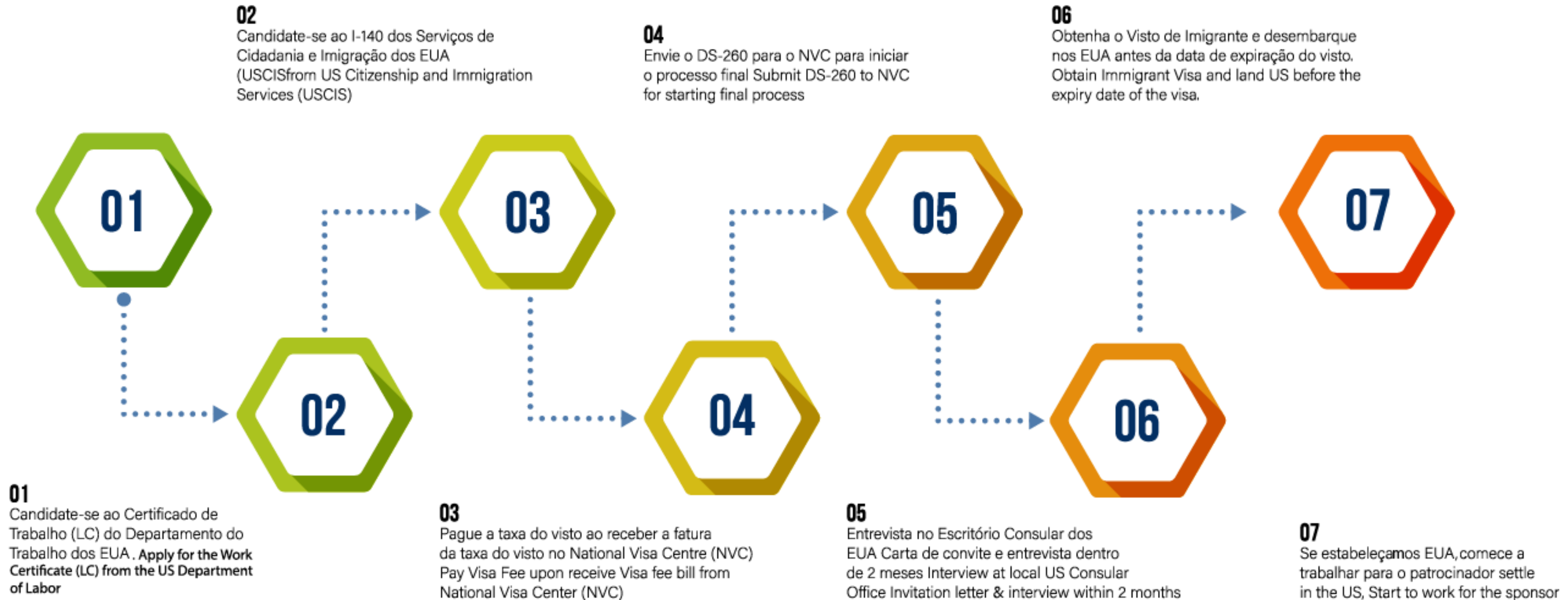

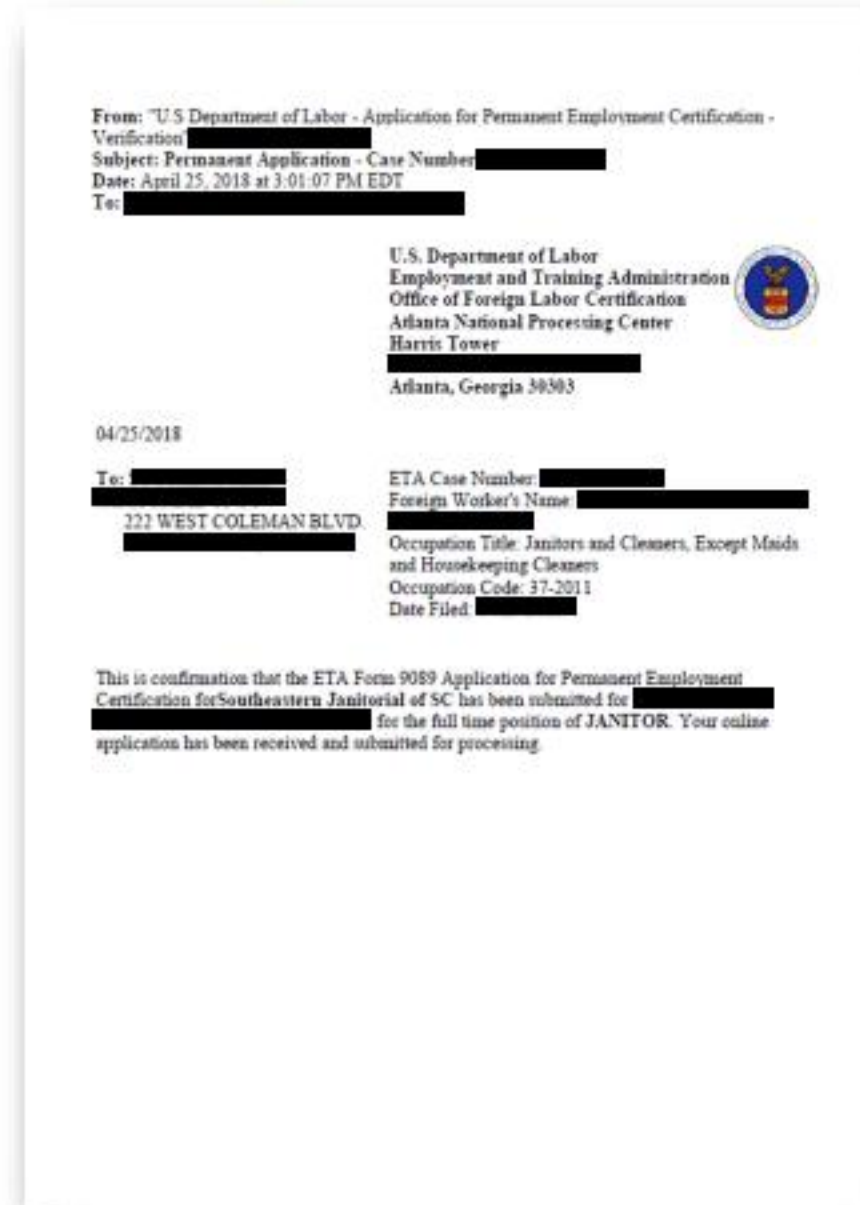

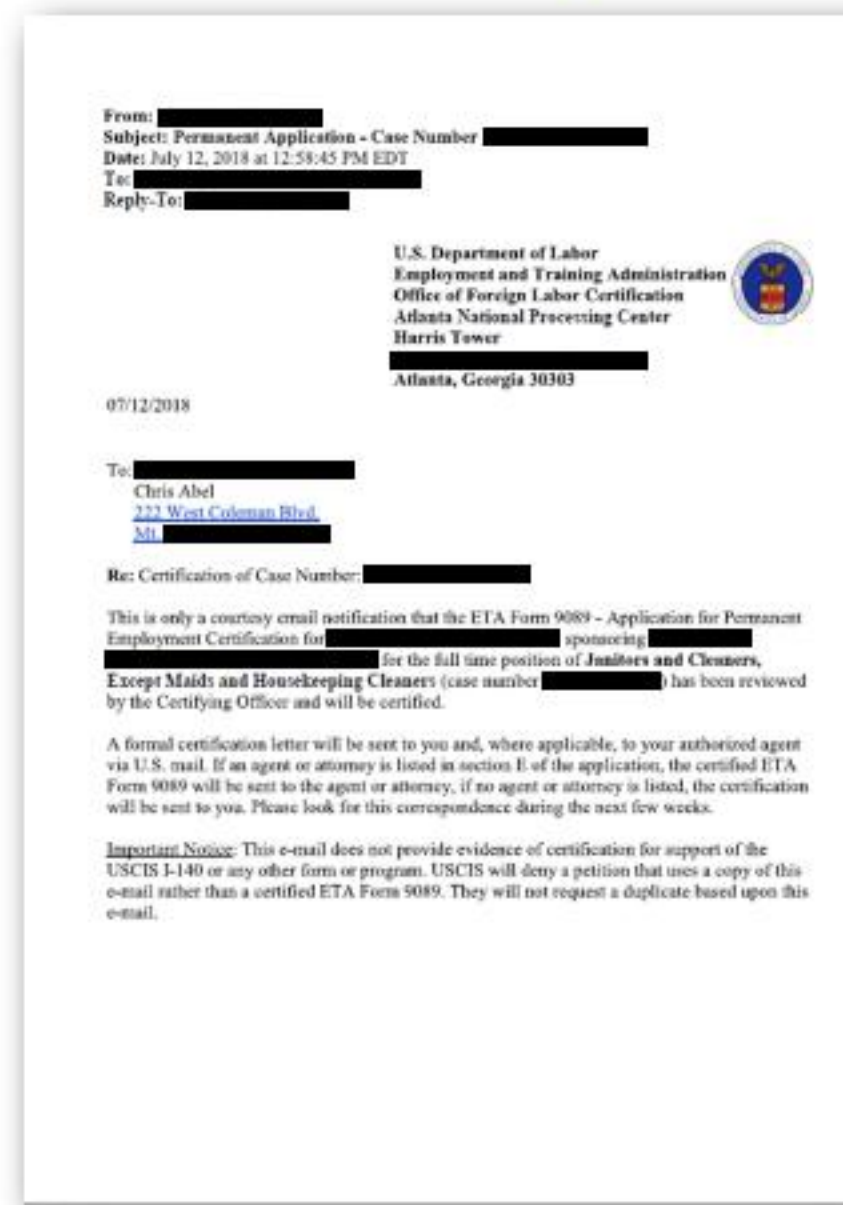
